# A Message from Price Warwick, Jr. Business Manager/Financial Secretary

Dear Brothers and Sisters:

Before the July meeting RENEW grilled and served fajitas. We had 48 members attend and enjoy the fellowship and food. There were 4 new members that took the oath and were welcomed into the IBEW.

We approved the pension applications for Charles Hays II (18), Carl Rank (36), John McKanna (23), and Dan Hemann (25). We wish them a long and healthy retirement.

Barry Williams won the July monthly door prize. No one won the recurring door prize so it will be \$684.00 at the August 6<sup>th</sup> meeting.

There is a Code of Excellence class on Saturday, July 20<sup>th</sup>, 8am-12 at the Training Center, email Cesar at cmartinez@ibew20.org to sign up. There is no cost to attend but seating is limited so get on the list soon.

The Bylaws Committee met before the meeting to review a proposed change and recommended it to the membership for consideration. The first reading took place at the June 2<sup>nd</sup> meeting and will be voted on at the August 6<sup>th</sup> meeting. The proposed change is as follows:

#### Existing Language:

#### ARTICLE XII

## **Death Benefit Fund**

Sec. 4.Upon the death of a participant who has been a participant for at least twelve (12) months immediately prior to his death, each participant shall be assessed \$3.00 if the balance in the Death Benefit Fund is less than \$30,000.00. This assessment shall be due and payable within thirty (30) days after the date of the death of a participant and all monies collected from this assessment shall be deposited in the Death Benefit Account.

Sec. 5."A" members in good standing in this Local Union and former members on pension withdrawal who have participated in this plan for one (1) year immediately prior to death shall be eligible for a Death Benefit equal to \$3.00 times the number of remaining members or \$5,000.00, whichever is lesser, to be paid in the following manner:

- (a) If the participant is indebted to this Local union, such indebtedness shall be deducted from the Death Benefit.
- (b) After deduction of the indebtedness of the deceased, if any, the balance remaining, if any, shall be paid to the beneficiary or beneficiaries designated by the participating member in the IBEW Pension Benefit Fund.

#### Proposed Language:

## ARTICLE XII

## **Death Benefit Fund**

- Sec. 4.Upon the death of a participant who has been a participant for at least six (6) months immediately prior to his death, each participant shall be assessed \$3.00. This assessment shall be due and payable within thirty (30) days after the date of the death of a participant and all monies collected from this assessment shall be deposited in the Death Benefit Account.
- Sec. 5."A" members in good standing in this Local Union and former members on pension withdrawal who have participated in this plan for one (1) year immediately prior to death shall be eligible for a Death Benefit equal to \$3.00 times the number of remaining members or \$6000.00, whichever is lesser, to be paid in the following manner:
- (a) If the participant is indebted to this Local union, such indebtedness shall be deducted from the Death Bene fit.
- (b) After deduction of the indebtedness of the deceased, if any, the balance remaining, if any, shall be paid to the beneficiary or beneficiaries designated by the participating member in the IBEW Pension Benefit Fund.

All other sections to remain unchanged.
