## A Message from A. C. McAfee Business Manager/Financial Secretary

Dear Brothers and Sisters:

The Local Union 20 Building Corporation had a Special Called Meeting on Tuesday, Feb. 24, 2009 to consider whether to continue with the purchase of the land from the JATC and the construction of a new office and meeting hall for the Local Union, or to delay construction for a year due to the economy.

There was much discussion after a presentation by the Business Manager, and then the members ***OVERWHELMINGLY*** passed a motion to continue, without any further delay, with the original plan to purchase the land and construct the building.

We purchased the land and completed the closing papers on Friday, March 6, 2009. We now own the land. By the time that you receive this newsletter, we will probably have already broken ground to begin construction. Naturally, weather can delay everything, especially this time of year.

The General Contractor is DFW Construction and Maintenance of Fort Worth and Morley/Moss will be the Electrical Contractor. All of the other sub-contractors have not been identified at this time. We are attempting to use all union subs.
