## PROPOSED BYLAWS CHANGE

The following Bylaws change will have the second reading and be voted on at the General Membership Meeting on December 1, 2009. This change is due to the dissolving of the Building Corporation. The proposed Bylaws change follows the Pattern Bylaws language sent to all Business Managers by Intl. Pres. Hill.

Replace existing ARTICLE XIII with a new Article.

### **ARTICLE XIII**

#### **Property of IBEW Local Union 20**

- Sec. 1.** The Local Union's building, and other property, located at 684 and 688 W. Tarrant Road, Grand Prairie, Texas 75050, shall be owned by and in the name of IBEW Local Union No. 20.
- Sec. 2.** The Local Union members shall, by majority vote of those present and voting, decide all issues concerning the building and other real property of the Local Union. A majority of the members voting shall constitute a quorum.
- Sec. 3.** To promote and carry out the aims and interests of the Local Union, no real property of the Local Union shall be sold, leased, encumbered, or disposed of, nor shall any real property be purchased or otherwise acquired, except by a majority of the Local Union members present and voting, following notice to all members, as provided in Section 4.
- Sec. 4.** All members of the Local Union shall be notified in writing of the nature of a resolution of the announced intention to dispose of or acquire real property at least fifteen (15) days before the date of the meeting. Said resolution shall be read at such regular or specially-called meeting. The members shall then vote on the resolution.
- Sec. 5.** All decisions concerning the disposition or acquisition of real property by the Local Union must be approved, in advance, by the International President.

### **GROUP I STATUS LIMITATION**

In a letter from Intl. Pres. Hill dated December 23, 2008, all IBEW Local Unions in the United States having Inside and Outside jurisdiction were notified of the revision to Article IV, Referral Language, Section 5.05 (Category I language), which was changed to include the "Group I Limitation" language.

In a letter from Intl. Pres. Hill dated October 22, 2009, all IBEW Local Unions were informed of the Electronic Registration for Group I Status Limitation Referral Language as follows:

"Group I status shall be limited to one Local Union at one time. An applicant who qualifies for Group I in a Local Union shall be so registered electronically and remain on Group I in that Local Union unless and until the applicant designates another Local Union as his or her Group I Local Union. If an applicant qualifies for Group I status in a Local Union other than his or her home Local Union and designates that Local as his or her Group I Local Union, the Business Manager of the new Group I status Local Union shall, by electronic means, notify the Business Manager of the applicant's former Group I status Local Union. The Business Manager shall notify the employer of an employee whose group status changes under this provision."

Effective November 1, 2009, the electronic registration process will begin via the Electronic Reciprocity Transfer System (ERTS). All members will be defaulted to the home local as designated on their official dues receipt. That status will remain unchanged until an applicant qualifies to another local according to provisions of the Category I language. As stated in the language, this can only be accomplished upon meeting the qualifications of the newly designated local and communication to the applicant's former Group I status local.

As this process is implemented, the membership will benefit as a whole by eliminating the possibility of duplicate Group I status.
